4	SYNOPSIS:
5	Pursuant to a law that was enacted during the
6	2022 Regular Session, a retail licensee of the
7	Alcoholic Beverage Control Board may sell alcoholic
8	beverages using curbside pick-up or takeout services.
9	This bill would revise the amount of alcoholic
10	beverages that may be sold in a 24-hour period to match
11	the amounts that may be sold by a delivery service
12	license.

19	Relating to alcoholic beverages; to amend Section 2 of
20	Act 2022-431 of the 2022 Regular Session, now appearing as
21	Section 28-3A-13.3, Code of Alabama 1975, to revise the
22	amounts of alcoholic beverages that may be sold curbside.
23	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
24	Section 1. Section 2 of Act 2022-431 of the 2022
25	Regular Session, now appearing as Section 28-3A-13.3, Code of
26	Alabama 1975, is amended to read as follows:

28	(a) A licensee of the Alcoholic Beverage Control Board

who holds a license that allows the sale of alcoholic 29 30 beverages for on-premises consumption or for off-premises 31 consumption, or both, may sell alcoholic beverages, for 32 off-premises consumption only, using curbside pick-up or 33 takeout services. 34 (b) All alcoholic beverages sold pursuant to this 35 section must be in sealed, unopened containers and as follows: 36 (1) Liquor may be sold in any size bottle container, 37 provided the total amount of liquor sold may not exceed one liter per customer, except restaurant licensees' liquor sales 38 39 may not exceed 375 milliliters per customer and must be accompanied by a food order. 40 41 (2) Table wine may be sold in any size bottle 42 container, provided the total amount of table wine sold may 43 not exceed 1500-9,000 milliliters or the equivalent of 12 750 milliliter bottles of tabe wine per customer. 44 45 (3) Beer, with the exception of draft beer, may be sold 46 in any packaging and in any size container, provided the total 47 amount of beer sold may not exceed 288 ounces 120 12-ounce 48 containers of beer per customer. 49 (4) Draft beer may be sold only in areas where draft 50 sales are authorized and sealing requirements are met, 51 provided the total amount of draft beer sold may not exceed 52 288 ounces per customer.

(c) Any employee handling alcoholic beverages for a pick-up or takeout order must be 21 years of age or older and must verify that the recipient is 21 years of age or older.

56 (d) The licensee is responsible for complying with all



57 other laws of this title and rules adopted by the board 58 thereunder."

59 Section 2. This act shall become effective on the first 60 day of the third month following its passage and approval by 61 the Governor, or its otherwise becoming law.
