1 Enrolled, An Act,

3 Relating to Cherokee County; to amend Section
4 45-10-201, Code of Alabama 1975, to provide for the transfer
5 of the duties of the license commissioner to the revenue
6 commissioner; and to make nonsubstantive, technical revisions
7 to update the existing code language to current style.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. Section 45-10-201, Code of Alabama 1975, is
10 amended to read as follows:

11 "§45-10-201

12 There is hereby created within ~~the~~ Cherokee County
13 ~~Courthouse~~ the permanent office of license commissioner. The
14 duties and responsibilities of the office shall be performed
15 by the ~~Probate Judge~~ Revenue Commissioner of Cherokee County
16 as herein provided. The county commission shall furnish the
17 license commissioner with suitable quarters and provide the
18 necessary forms, books, stationery, records, equipment, and
19 supplies, except such stationery, forms, and supplies as are
20 furnished pursuant to law by the state Department of Finance
21 or the state Comptroller. The county commission shall ~~insure~~
22 ensure that the office has sufficient help and shall provide
23 clerks and other assistants for the office as shall be
24 necessary, from time to time, for the proper and efficient
25 performance of the duties of the office. The ~~probate judge~~
26 license commissioner is hereby authorized to employ the clerks
27 and other assistants, and to fix their compensation; however,
28 the number and compensation of clerks and other assistants

29 shall be subject to the approval of the county commission. The
30 compensation of the clerks and assistants shall be paid
31 ~~monthly~~ biweekly out of the general fund of the county in the
32 same manner as other county employees are paid. The duties of
33 the license commissioner shall not include the renewal of
34 driver licenses or the issuance or renewal of business,
35 hunting, or fishing licenses."

36 Section 2. The provisions of this act are supplemental
37 to any laws relating to the operation of the Office of the
38 Cherokee County License Commissioner.

39 Section 3. This act shall become effective on July 1,
40 2023, following its passage and approval by the Governor, or
41 its otherwise becoming law.
