A BILL
TO BE ENTITLED
AN ACT

Relating to Lee County; to amend Section 45-41-242.06, Code of Alabama 1975, to change the name of the Auburn-Opelika Convention and Visitors Bureau to Auburn-Opelike Tourism; and to further provide for the membership and operation of Auburn-Opelika Tourism.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 45-41-242.06, Code of Alabama 1975, is amended to read as follows:

"§45-41-242.06

(a) There shall be created and established a bureau known as the Auburn-Opelika Convention and Visitors Bureau Tourism.

(b) The bureau shall be composed of ~~five~~ the following board members:-

(1) ~~The judge of probate~~ Chair of the Lee County Commission or his or her appointee; ~~.-~~

(2) ~~the mayors or their appointees from the Cities of Auburn and Opelika; and one~~ The Mayor of the City of Auburn or his or her appointee.

(3) The Mayor of the City of Opelika or his or her

52 Section 2. This act shall become effective on the first
53 day of the third month following its passage and approval by
54 the Governor, or its otherwise becoming law.
