11	Section 1. The boundary lines and corporate limits of
12	the municipality of the City of Dadeville in Tallapoosa County
13	are altered, rearranged, and extended to include within the
14	corporate limits of the municipality, in addition to the lands
15	now included, all of the following territory:
16	Commence at the Southwest corner of Section 31,
17	Township 21 North, Range 23 East, Tallapoosa County, Alabama;
18	thence North 83 degrees 36 minutes 04 seconds East, 4051.10
19	feet to a capped pin (#11282) found at the Point of Beginning;
