23	Section 1. Section 36-17-8.2 of the Code of Alabama

29 participating in the Employees' Retirement System or the 30 Teachers' Retirement System without suspension of his or her 31 retirement allowance provided that (1) the person is not 32 employed in a permanent full-time capacity and (2) the 33 person's compensation from the employer in calendar year 2016 34 does not exceed thirty thousand dollars (\$30,000). Beginning 35 in calendar year 2017, and each calendar year thereafter, the 36 annual earning limit shall be increased by the same percentage 37 increase as the increase in the Consumer Price Index for all urban consumers as published by the U.S. Department of Labor, 38 39 Bureau of Labor Statistics. Any increase in the annual earning limit shall be rounded to the next lowest multiple of one 40 thousand dollars (\$1,000) with any amount in excess of the one 41 42 thousand dollar (\$1,000) multiple considered in determining 43 the increase for the following year. Each adjustment shall be based on the increase in the index for the preceding 12-month 44 45 period ending on September 30 and the increase shall be 46 effective for the following calendar year.

(b) Any person serving as an elected official who has retired from the Employees' Retirement System may serve for compensation in an elected public office with the state, a county, or an incorporated municipality without suspension of retirement benefits; provided that under no circumstances shall such a person participate in or accrue additional benefits under the Teachers' Retirement System or the Employees' Retirement System, and provided that under no circumstances shall a person whose retirement is based upon service as an elected official continue in or return to—such

the office and receive both pension benefits and salary; provided further, that this subsection shall apply to elected officials whose participation in the Teachers' Retirement System or the Employees' Retirement System is constitutionally required to be upon the same terms and conditions as specified by law for other employees in the retirement system if such the elected official's compensation does not exceed the annual earning limits provided in subsection (a).

- provision of this section subsection (a) and subsection (b) is placed upon the employing authority, and each retiree performing duties under this section those subsections shall certify to the employer any information required in order to carry out this section those subsections. The retiree shall provide written notice of the postretirement employment under this section those subsections to the Employees' Retirement System and employing authority within 30 days after the date the retiree knows or should know that he or she will be performing duties on a full-time or permanent basis or will earn an amount in excess of the annual earning limit under this section.
- (d) Any individual who is retired under the Employees'

 Retirement System and was classified as a law enforcement

 officer, as defined in Section 36-27-59(a), may perform duties
 as a school resource officer, as defined in Section 16-1-44.1,
 without suspension of his or her retirement allowance in any
 capacity with no annual earning limit."
- Section 2. This act shall become effective immediately
