6 WHEREAS, Chief Jimmie Flanagan served the State of  
7 Alabama in an exemplary manner as the Chief of Police for  
8 the Alabama Port Authority from January 2009 until May 2023;  
9 and

10 WHEREAS, the Alabama Port Authority Police Department  
11 is the third largest in Mobile County; and

12 WHEREAS, Chief Jimmie Flanagan joined the Alabama  
13 Port Authority as Assistant Chief in 2004 after a  
14 distinguished career in Alabama law enforcement leadership  
15 roles prior to his appointment, including, Chief of Police  
16 for the Elberta Police Department; Captain and Chief  
17 Investigator for the Foley Police Department; and Commander  
18 of the Patrol Division of the Gadsden Police Department; and

19 WHEREAS, Chief Flanagan's law enforcement career in  
20 Alabama spans a remarkable 50 years from patrolman to police  
21 chief; and

22 WHEREAS, prior to entering law enforcement, Chief  
23 Flanagan served his country with honor in the United States  
24 Army during the Vietnam War and, subsequently, as a member  
25 of the Alabama National Guard where he retired as First  
26 Sergeant of the 258th Chemical Battalion in Gadsden,

28 WHEREAS, Chief Flanagan is a 1981 graduate of

29 Jacksonville State University with a Bachelor of Science  
30 Degree in Criminal Justice; in 1985, he graduated from the  
31 FBI National Academy; and

32 WHEREAS, Chief Flanagan resides in Spanish Fort,  
33 Alabama, with his wife Debbie; he is the proud father of  
34 five children, 11 grandchildren, and one great-grandchild;

36 WHEREAS, Chief Jimmie Flanagan will retire from the  
37 Alabama Port Authority on April 30, 2023, after 50 years of  
38 service to local law enforcement agencies and the State of
