6	TO BE ENTITLED
7	AN ACT
8	To alter, rearrange, and extend the boundary lines and
9	corporate limits of the municipality of Spanish Fort in
10	Baldwin County.
11	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
12	Section 1. The boundary lines and corporate limits of
13	the municipality of Spanish Fort in Baldwin County are altered
14	and rearranged and extended to include within the corporate
15	limits of the municipality, in addition to the lands now
16	included, all of the following territory:
17	Parcel 1
18	Beginning at the Northwest corner of Lot 17, Spanish Fort
19	Estates, Twenty-Fourth Addition, Phase One, as per plat
20	recorded on Slide No. 2058-A of the Probate Court Records of
21	Baldwin County, Alabama; thence along the North boundary of
22	said Spanish Fort Estates, Twenty-Fourth Addition, Phase One,
23	run as follows: S 20 degrees 56' 24" W 217.16 feet, N 53
24	degrees 21' 01" W 164.27 feet, N 65 degrees 09' 23" W 50.00
25	feet, N 59 degrees 30' 46" W 137.59 feet, N 26 degrees 47' 07"
26	W 122.98 feet to the Northwest corner of said Spanish Fort
27	Estates, Twenty-Fourth Addition, Phase One; thence run N 75

113	Section 2. In accordance with Section 11-42-6 of the
114	Code of Alabama 1975, a map showing the proposed territory to
115	be altered and rearranged and extended from the municipality
116	of Spanish Fort is on file and open to public inspection in
117	the Office of the Judge of Probate in Baldwin County, Alabama.
118	Section 3. This act shall become effective on the first
119	day of the third month following its passage and approval by
120	the Governor, or its otherwise becoming law.
