SYNOPSIS:

Under existing law, the contracts an athletic association enters into are not subject to state review.

This bill would require all contracts entered into by an athletic association be reviewed by the Contract Review Permanent Legislative Oversight Committee.

This bill would also prohibit public K-12 schools from membership in athletic associations under certain circumstances.

A BILL  
TO BE ENTITLED  
AN ACT

Relating to athletic associations; to require an athletic association's contracts be reviewed by the Contract Review Permanent Legislative Oversight Committee; and to prohibit public K-12 schools from membership in athletic associations under certain circumstances.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. (a) For purposes of this section the term "athletic association" means any athletic organization

29 operating in the state with authority over its member  
30 institutions' athletic programs, which receives public funds  
31 in any form, and whose member institutions make use of public  
32 facilities.

33 (b) All contracts or agreements entered into by or on  
34 behalf of any athletic association shall first be reviewed by  
35 the Contract Review Permanent Legislative Oversight Committee.  
36 Any athletic association, regardless of funds used to pay a  
37 contract, shall be subject to the requirements and procedures  
38 imposed by the committee with regard to contract review.

39 (c) No public K-12 school may be a member of an  
40 athletic association whose contracts are not reviewed by the  
41 Contract Review Permanent Legislative Oversight Committee.

42 Section 2. This act shall become effective on the first  
43 day of the third month following its passage and approval by  
44 the Governor, or its otherwise becoming law.
