14	TO BE ENTITLED
15	AN ACT

17	To make supplemental appropriations for the fiscal year
18	ending September 30, 2023: from the Veterans' Assistance Fund
19	to the Department of Veterans' Affairs in the amount of
20	\$10,000,000, and from the State General Fund to various
21	agencies and entities a total amount of \$188,573,865.
22	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
23	Section 1. In addition to all other appropriations
24	heretofore and hereafter made, there is hereby appropriated
25	\$10,000,000 from the Veterans' Assistance Fund to the
26	Department of Veterans' Affairs for the fiscal year ending
27	September 30, 2023.
28	Section 2. In addition to all other appropriations

- 29 heretofore and hereafter made, there is hereby appropriated a
- 30 total of \$188,573,865 from the State General Fund to the
- 31 following agencies and entities for the purposes specified
- 32 below for the fiscal year ending September 30, 2023:
- 33 (1) To the Department of Economic and Community Affairs
- 34 for structural repairs and maintenance at the Montgomery
- 35 Surplus Warehouse, \$5,000,000.
- 36 (2) To the Supreme Court for one-time repairs and
- 37 maintenance of the Heflin-Tolbert building, \$1,935,000.
- 38 (3) To Debt Service, \$39,911,517. Of this amount,
- 39 \$485,556 shall be used for a required payment for the General
- 40 Obligation Bond Series 2022-A, and \$39,425,961 shall be used
- 41 to satisfy the remaining debt service obligation for the
- 42 General Obligation Bonds Series 2013-A and 2013-B.
- 43 (4) To the Department of Geological Survey, \$1,057,696.
- Of this amount, \$57,696 shall be used for the conversion of
- 45 viewing rooms into office space, and \$1,000,000 shall be used
- 46 to move rock cores, samples, and other materials and equipment
- 47 to the new Core and Sample Repository, or expenses associated
- 48 with ongoing capital projects.
- 49 (5) To the Department of Senior Services for meals
- through the end of the current emergency contract, \$1,052,652.
- 51 (6) To the Department of Mental Health, \$43,000,000. Of
- 52 this amount, \$23,000,000 shall be used for construction costs
- for Taylor Hardin; \$10,000,000 shall be used to assist with
- 54 the reopening of Pickens County Hospital and renovating for
- psychiatric and child services; and \$10,000,000 shall be used
- for the East Alabama Medical Center for psychiatric and child

- 57 services.
- 58 (7) To the Department of Forensic Sciences, \$4,800,000.
- Of this amount \$4,000,000 shall be used for lab equipment for
- the Huntsville Lab, and \$800,000 shall be used for equipment
- for the new Dothan Lab.
- 62 (8) To the Military Department for Huntsville Armory
- 63 construction, \$5,667,000.
- (9) To the Bureau of Pardons and Paroles for moving
- 65 expenses, \$650,000.
- (10) To the Department of Corrections for the Offender
- Management Program, \$5,500,000.
- 68 (11) To the General Fund Budget Reserve Fund,
- 69 \$50,000,000.
- 70 (12) To the State Law Enforcement Agency for the
- 71 Computerized Criminal History (CCH) System, \$8,000,000.
- 72 (13) To the Department of Finance for elevator upgrades
- 73 in the State Capitol, \$8,000,000.
- 74 (14) To the Governor's Mansion Authority for the roof
- and repairs at the Hill House, \$2,000,000.
- 76 (15) To the Alabama Forestry Commission, \$12,000,000.
- 77 Of this amount, \$2,000,000 shall be used for the replacement
- of firefighting equipment and aging equipment, and \$10,000,000
- 79 shall be used for grants to volunteer fire departments and
- 80 rescue squads.
- 81 Section 3. In addition to all other appropriations
- 82 heretofore and hereafter made, there is hereby appropriated
- 83 such amounts as may be necessary for public funds transferred
- into the State Treasury, in accordance with Executive Order

- 85 No. 726.
- Section 4. This act shall become effective immediately
- upon its passage and approval by the Governor, or upon its
- 88 otherwise becoming law.
