SYNOPSIS:

This bill makes appropriations for the ordinary expenses of the executive, legislative, and judicial agencies of the State, for other functions of government, for debt service, and for capital outlay for the fiscal year ending September 30, 2024.

A BILL
TO BE ENTITLED
AN ACT

To make appropriations for the ordinary expenses of the executive, legislative, and judicial agencies of the State, for other functions of government, for debt service, and for capital outlay for the fiscal year ending September 30, 2024.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The monies in Section 2 are appropriated from the named funds for the 2024 fiscal year to the state agencies indicated, as the amounts to be used to pay the expenditures of the named agencies, and are in lieu of all monies appropriated for these purposes in other sections of the Alabama Statutes.

For the purpose of this act, the amounts herein for expenditures are listed by programmatic area and the totals for all programs are shown by the source of funds. It is

28 intended that only the herein named funds be appropriated in
29 the amounts specified to the named agencies and that the
30 following definitions shall be applicable.

31 "Total" shall mean the aggregate total appropriation of
32 all funding sources.

33 "Program" shall mean specific governmental services
34 required to achieve a specific objective. A program shall be
35 directed to meeting the need of an identified clientele, or
36 group of recipients or beneficiaries, and shall be expended
37 only for such purposes.

38 "Capital Outlay" shall mean expenditures which result
39 in the acquisition and/or addition to items, such as land or
40 buildings, which have an appreciable and calculable period of
41 usefulness in excess of one year, and shall be expended only
42 for such purposes.

43 "Debt Service" shall mean an expenditure for the
44 payment of interest and principal on bonded debt obligations
45 of the State, and shall be expended only for such purposes.

46 "Federal and Local Funds" shall mean all gifts, grants,
47 contributions, or entitlements, including grants by the
48 Congress of the United States, municipalities or counties.

49 Section 2. (a) There is hereby appropriated the amounts
50 set forth herein for the ordinary expenses of the executive,
51 legislative, and judicial agencies of the State, for other
52 functions of government, for debt service, and for capital
53 outlay for the fiscal year ending September 30, 2024, to be
54 paid out of any monies hereinafter specified, from such other

55 funds and accounts as may be designated, or so much thereof as
56 may be necessary, and the total amount to be expended for the
57 items for which the appropriation is herein made shall not
58 exceed the amount provided therefor, except as provided in the
59 Budget Management Act of 1976, Sections 41-19-1 through
60 41-19-12, Code of Alabama 1975. Provided, however, that
61 regardless of the ending date of any pay period which has been
62 or may be established by the Legislature for the payment of
63 salaries of state employees, the entire payment due shall be
64 made from the fiscal year's appropriation in which the pay
65 date falls.

66 (b) All appropriations made in Section 3 shall be at
67 the program level. Any directed expenditure of funds below a
68 program shall be from funds appropriated for the program.

There is further appropriated to the 292 Alabama Alcoholic Beverage Control Board, after provision has been made for the 293 other expenditures herein authorized, such sums as are or may be necessary to 294 purchase the alcoholic beverages which are essential to maintain adequate stocks and 295 inventory for an economic and successful sales operation. In addition to the above 296 appropriation, it is further provided that, in the event any county or municipality 297 of the state shall, during the fiscal period covered by this appropriation by proper 298 referendum, authorize the legal sale of malt and brewed beverages within such county 299 or municipality there is further appropriated, in addition to the amount herein set 300 out, an amount comparable to that expended during the prior fiscal year for beer and 301 license tax supervision within counties or municipalities of similar size and 302 population. 2856 Section 4. In addition to the amounts otherwise
2857 appropriated in this act, there is hereby appropriated from
2858 the several funds in the State Treasury, except the Education
2859 Trust Fund, and in the same proportion as the salaries of the
2860 several State officials and employees are paid, such
2861 additional amounts as may be necessary to pay for a two
2862 percent (2.0%) salary increase enacted in the 2023 Regular
2863 Session. The additional amounts appropriated in this section
2864 from the State General Fund shall not exceed \$14,500,000 for
2865 the fiscal year ending September 30, 2024. The Director of
2866 Finance shall ensure that first priority shall be given to all
2867 State General Fund payrolls, including the payroll of the
2868 Legislature. State agencies shall receive additional
2869 allocations from the appropriation made in this section from
2870 the State General Fund in amounts necessary to increase total
2871 salaries paid from the State General Fund by two percent. The
2872 remainder of this appropriation from the State General Fund
2873 may be allotted by the Director of Finance to those agencies
2874 which receive transfers from the State General Fund.

2875 Section 5. In addition to the amounts otherwise
2876 appropriated in this act, there is hereby appropriated from
2877 the State General Fund such additional amounts for an
2878 inflationary increase in the same proportion as expenditures
2879 of agencies. The additional amounts appropriated in this
2880 section from the State General Fund shall not exceed
2881 \$50,000,000 for the fiscal year ending September 30, 2024. The
2882 Director of Finance shall ensure that first priority shall be

2883 given to all State General Fund agencies, including the
2884 Legislature. State agencies shall receive additional
2885 allocations from the appropriation made in this section from
2886 the State General Fund for inflation, excluding inflation of
2887 payroll, benefits, capital projects, and grants. The remainder
2888 of this appropriation from the State General Fund may be
2889 allotted by the Director of Finance to those agencies which
2890 receive transfers from the State General Fund.

2891 Section 6. The State General Fund appropriations in
2892 this act anticipate a beginning balance in the State General
2893 Fund for fiscal year 2024, excluding reversions and
2894 adjustments, of \$142,900,549. If the State General Fund
2895 beginning balance for Fiscal Year 2024, excluding reversions
2896 and adjustments, is greater than the above stated anticipated
2897 amount, then the first \$3,000,000 of the unanticipated and
2898 unappropriated beginning balance is hereby appropriated from
2899 the State General Fund to the Legislative Services Agency for
2900 expenses related to the completion, implementation, and
2901 operation of the new bill and budget drafting system for the
2902 Legislature. If after making the above appropriation, there
2903 are still funds remaining above the stated amount, then the
2904 next \$50,000,000 of the unanticipated and unappropriated
2905 beginning balance is hereby appropriated from the State
2906 General Fund to the Department of Corrections - Correctional
2907 Capital Improvement Fund established in Section 14-2-21(c),
2908 Code of Alabama 1975.

2909 Section 7. Notwithstanding any other provisions of this

2910 act or any other act, any amounts from appropriations for the
2911 fiscal year ending September 30, 2023, to the various state
2912 agencies in this act which were unexpended and reverted on
2913 September 30, 2023, are hereby reappropriated to the
2914 respective offices for the fiscal year beginning October 1,
2915 2023.

2916 Section 8. In addition to all other appropriations
2917 heretofore or hereafter made, there is hereby appropriated
2918 such amounts as may be necessary for the fiscal year ending
2919 September 30, 2024, to the Retirement Systems of Alabama from
2920 the Senior Services Trust Fund to comply with Section
2921 41-15C-1, Code of Alabama 1975.

2922 Section 9. In addition to all other appropriations
2923 heretofore and hereafter made, there is hereby appropriated
2924 such amounts as may be necessary for public funds transferred
2925 into the State Treasury, in accordance with Executive Order
2926 No. 726.

2927 Section 10. In addition to all other appropriations
2928 heretofore or hereafter made, there is hereby conditionally
2929 appropriated any and all amounts from tobacco settlement or
2930 litigation for the fiscal year ending September 30, 2024. The
2931 amounts are conditioned upon the State of Alabama receiving
2932 revenue from tobacco settlement or litigation and upon the
2933 recommendation of the Director of Finance, the Chairs of the
2934 House Ways and Means-General Fund Committee and the Senate
2935 Finance and Taxation-General Fund Committee, and the approval
2936 of the Governor. The conditional appropriation made herein

2937 shall be allocated pursuant to Sections 41-10-620 through
2938 41-10-639 and Sections 41-15B-1 through 41-15B-8, Code of
2939 Alabama 1975.

2940 Section 11. Except as may be herein otherwise provided,
2941 amounts herein specifically appropriated shall be in lieu of
2942 the amounts heretofore provided or appropriated by law for
2943 such purposes. The amounts herein appropriated are the maximum
2944 amounts to be expended for the purposes herein designated and
2945 in no event shall the maximum expenditure provided for any
2946 items of expense exceed the amount allocated herein except as
2947 may be further provided for under this act, as provided in the
2948 Budget Management Act of 1976, Sections 41-19-1, et seq., Code
2949 of Alabama 1975, and those appropriations herein made, except
2950 appropriations to the Alabama Alcoholic Beverage Control Board
2951 for the purchase of alcoholic beverages, are and shall be
2952 subject to the terms, conditions, provisions and limitations
2953 of Sections 41-4-80, et seq., Code of Alabama 1975, and the
2954 Budget Management Act of 1976, Sections 41-19-1, et seq., Code
2955 of Alabama 1975.

2956 Section 12. Any surplus remaining in any appropriation
2957 herein made from the State General Fund to any office,
2958 department, bureau, board, commission, or agency may be
2959 transferred, on order of the Governor, to any other
2960 appropriation herein made from the State General Fund when
2961 such appropriation to any office, department, bureau, board,
2962 commission, or agency is insufficient to pay salaries in that
2963 office, department, bureau, board, commission, or agency.

2964 Section 13. (a) In addition to appropriations herein
2965 made, all gifts, grants, insurance proceeds, contributions, or
2966 entitlements, in excess of the amount carried in this act,
2967 including grants by the Congress of the United States,
2968 municipalities, or counties, to any department, division,
2969 board, bureau, commission, agency, institution, office, or
2970 officer of the State of Alabama are hereby appropriated and,
2971 in the event the same are recurring, are reappropriated to
2972 such department, division, board, bureau, commission, agency,
2973 institution, office, or officer to be used only for the
2974 purpose or purposes for which the grant or contribution was or
2975 shall be made. Further, all state, county, municipal, and
2976 educational entities are authorized to disburse such sums as
2977 deemed necessary by mutual agreement among said entities, the
2978 State of Alabama, and the Department of Examiners of Public
2979 Accounts to partially defray the cost of auditing services
2980 performed by said agency. All such sums are hereby
2981 appropriated and reappropriated if necessary to the Department
2982 of Examiners of Public Accounts for audit services, to be
2983 expended through the fund established by Section 41-5A-22,
2984 Code of Alabama 1975.

2985 (b) Provided, however, this section shall not apply to
2986 the Coronavirus State Fiscal Recovery Fund or the Coronavirus
2987 Capital Projects Fund provided by the Congress of the United
2988 States to the State of Alabama from the American Rescue Plan
2989 Act of 2021, except for any balance of such funds remaining
2990 from any appropriations made for fiscal year 2023 that remain

2991 unspent at the end of fiscal year 2023 shall be reappropriated
2992 for the same purposes originally appropriated.

2993 (c) This section shall also not apply to any additional
2994 federal stimulus funds provided to the state in fiscal year
2995 2024 for purposes directly related to the coronavirus
2996 pandemic, other than additional funds provided for existing
2997 federal programs.

2998 Section 14. The Department of Examiners of Public
2999 Accounts is hereby authorized to examine as deemed necessary
3000 all appropriations herein made for compliance with the laws of
3001 the State of Alabama. Any examination performed shall be in
3002 accordance with the provisions of Title 41, Chapter 5A, Code
3003 of Alabama 1975. It is the intent of the Legislature that all
3004 state agencies cooperate with the Examiners of Public Accounts
3005 to provide the information necessary to conduct recovery
3006 audits as provided for in Section 41-5A-6, Code of Alabama
3007 1975.

3008 Section 15. Upon certification to the Director of
3009 Finance by the State Attorney General that a federal court has
3010 ordered the State of Alabama to pay claims, attorney fees, or
3011 other costs relating to said court order, funds are hereby
3012 appropriated to the affected department, board, bureau, or
3013 commission from the appropriate fund or funds of such
3014 department, board, bureau, or commission in the amount
3015 necessary to satisfy that court order. Such appropriations are
3016 in addition to any other appropriation heretofore or hereafter
3017 made in this appropriation act. Such appropriations are

3018 conditioned upon the availability of funds and a determination
3019 by the Director of Finance that existing appropriations are
3020 not available for the court-ordered payments.

3021 Section 16. All interest earned from funds paid into
3022 Account No. 0396 by Act 87-761, Act 88-947, Act 89-79, Act
3023 90-556, and Act 91-572 are hereby appropriated to the
3024 Governor's Contingency Fund to be spent at the discretion of
3025 the Governor. Any other interest earned by the state from
3026 Revenue Sharing Investments under the State and Local Fiscal
3027 Assistance Act of 1972, as amended, Public Law 92-512, 92nd
3028 Congress, together with any accruals or reversions thereon are
3029 hereby appropriated to the State General Fund.

3030 Section 17. All encumbered balances of a previous
3031 fiscal year appropriation, other than the exclusions
3032 authorized by this act or in Section 41-4-93, Code of Alabama
3033 1975, shall lapse no later than September 30 of the fiscal
3034 year immediately following the fiscal year for which the
3035 appropriation was made and shall revert to the credit of the
3036 State General Fund or earmarked fund from which the
3037 appropriation or appropriations were made.

3038 Section 18. The appropriations made herein to the
3039 departments, boards, offices, commissions, and agencies
3040 include the amounts necessary, and said departments, boards,
3041 offices, commissions, and agencies are hereby directed to make
3042 the transfer of funds to the State Personnel Department in
3043 said amounts enumerated in this act. All agencies enumerated
3044 in this act and receiving services from other governmental

3045 agencies enumerated in this act shall make full payment in a
3046 timely manner (as determined by the Department of Finance) for
3047 such services.

3048 Section 19. All funds collected under Section
3049 40-12-43.1, Code of Alabama 1975, between the effective date
3050 of Act 98-191 and September 30, 2023, are hereby appropriated
3051 to the Auburn University Center for Governmental Services for
3052 the administration of the examiner certification program
3053 established by the Alabama Local Tax Institute of Standards
3054 and Training as provided in Section 40-12-43.1, Code of
3055 Alabama 1975.

3056 Section 20. It is the intent of the Legislature that
3057 the funds appropriated to the Office of the Senate President
3058 Pro Tempore in subsection 6 of Section 3 of this act which are
3059 not otherwise designated may be expended by the Senate
3060 President Pro Tempore for the same purposes as are authorized
3061 for the Lieutenant Governor pursuant to Section 29-4-50, Code
3062 of Alabama 1975, and the Speaker of the House of
3063 Representatives pursuant to Section 29-4-60, Code of Alabama
3064 1975.

3065 Section 21. The appropriations made herein to the
3066 departments, boards, offices, commissions, and agencies
3067 include the amounts necessary to pay the SEIB. The SEIB rate
3068 shall be \$977 per month for each full-time employee for the
3069 fiscal year ending September 30, 2024. In addition to the
3070 amounts otherwise appropriated in this act, there is hereby
3071 appropriated from the State General Fund in the same

3072 proportion as the salaries of the several State officials and
3073 employees are paid, additional amounts to pay for the increase
3074 in employer contributions to SEIB. The additional amounts
3075 appropriated in this section from the State General Fund shall
3076 not exceed \$5,600,000 for the fiscal year ending September 30,
3077 2024. The Director of Finance shall ensure first priority
3078 shall be given to all State General Fund payrolls, including
3079 the payroll of the legislature. State agencies may receive
3080 additional allocations from the appropriation made in this
3081 section from the State General Fund in amounts necessary to
3082 pay for the increase. The remainder of this appropriation from
3083 the State General Fund may be allocated by the Director of
3084 Finance to those agencies which receive transfers from the
3085 State General Fund. The SEIB shall adjust the insurance
3086 program wherever appropriate to maintain the aforementioned
3087 fixed rate.

3088 Section 22. It is the intent of the Legislature that
3089 the Director of Finance shall notify the Chair of the House
3090 Ways and Means-General Fund Committee, the Chair of the Senate
3091 Finance and Taxation-General Fund Committee, and the
3092 Legislative Fiscal Officer of any interagency transfers, of
3093 any type, including contracting, of any of the funds
3094 appropriated in this act.

3095 Section 23. All nongovernmental entities, identified
3096 by the Legislative Services Agency, which are allocated funds
3097 in Section 3 of this act shall file a report with the Chairs
3098 of the House Ways and Means-General Fund Committee, the Senate

3099 Committee on Finance and Taxation-General Fund, Finance
3100 Director, and the Legislative Fiscal Officer prior to the
3101 start of the 2024 Regular Session, regarding the proposed
3102 expenditures and usage of the funds appropriated in the fiscal
3103 year ending September 30, 2024. The Legislative Services
3104 Agency shall provide notice to the identified nongovernmental
3105 entities within 60 days following enactment of this act
3106 regarding the reporting requirements and the methodology to
3107 submit reports and format to be used, which may include an
3108 online platform.

3109 Section 24. If any section, paragraph, sentence,
3110 clause, provision, or portion of this act or all or any
3111 portion of any appropriations herein made be held
3112 unconstitutional or invalid, it shall not affect any other
3113 section, paragraph, sentence, clause, provision, or portion of
3114 this act or any other appropriation or appropriations or
3115 portion thereof hereby made not in and of itself
3116 unconstitutional or invalid.

3117 Section 25. All laws or parts of laws, general,
3118 special, private, or local that are in conflict with or
3119 inconsistent with the provisions of this act are hereby
3120 expressly repealed.

3121 Section 26. Each agency of the state funded through the
3122 provisions of this act shall provide an equal opportunity for
3123 employment and business opportunities for all citizens of this
3124 state without regard to sex or race.

3125 Section 27. This act shall become effective October 1,
