8	WHEREAS, Alpha Phi Alpha Fraternity, Incorporated,
9	the first intercollegiate Greek-letter fraternity
10	established for African-Americans, was founded at Cornell
11	University in Ithaca, New York, on December 4, 1906, by
12	Henry Arthur Callis, Charles Henry Chapman, Eugene Kinckle
13	Jones, George Biddle Kelley, Nathaniel Allison Murray,
14	Robert Harold Ogle, and Vertner Woodson Tandy, known as the
15	"Jewels"; these men recognized the need for a strong bond of
16	brotherhood among African descendants in this country; and
17	WHEREAS, Alpha Phi Alpha Fraternity, Incorporated,
18	for 117 years has been a beacon of light to the community by
19	staying true to its aims of Manly Deeds, Scholarship, and
20	Love for all Mankind; and
21	WHEREAS, Alpha Phi Alpha Fraternity, Incorporated,
22	has produced over 200,000 members since their founding in
23	1906, and currently there are over 80,000 college-educated
24	living members that were inducted into 706 college and
25	alumni chapters in the United States, Europe, Asia, and the
26	Caribbean; and
27	WHEREAS, Alpha Phi Alpha Fraternity, Incorporated,
