12	TO BE ENTITLED
13	AN ACT
14	
15	To amend Section 17-14-70, Code of Alabama 1975, to
16	provide for the reapportionment and redistricting of the
17	state's United States Congressional districts for the purpose
18	of electing members at the General Election in 2024 and
19	thereafter, until the release of the next federal census.
20	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
21	Section 1. Section 17-14-70, Code of Alabama 1975, is
22	amended to read as follows:
23	"§17-14-70
24	(a) The State of Alabama is divided into seven
25	congressional districts as provided in subsection (b).
26	(b) The numbers and boundaries of the districts are
27	designated and established by the map prepared by the
28	Permanent Legislative Committee on Reapportionment and



29 identified and labeled as <u>Pringle Congressional Plan 1 Pringle</u> 30 <u>Congressional Plan 1-2023</u>, including the corresponding 31 boundary description provided by the census tracts, blocks, 32 and counties, and are incorporated by reference as part of 33 this section.

34 (c) The Legislature shall post for viewing on its 35 public website the map referenced in subsection (b), including 36 the corresponding boundary description provided by the census 37 tracts, blocks, and counties, and any alternative map, including the corresponding boundary description provided by 38 39 the census tracts, blocks, and counties, introduced by any member of the Legislature during the legislative session in 40 41 which this section is added or amended.

42 (d) Upon enactment of Act 2021-555, adding the act 43 amending this section and adopting the map identified in subsection (b), the Clerk of the House of Representatives or 44 45 the Secretary of the Senate, as appropriate, shall transmit 46 the map and the corresponding boundary description provided by 47 the census tracts, blocks, and counties identified in 48 subsection (b) for certification and posting on the public 49 website of the Secretary of State.

(e) The boundary descriptions provided by the certified map referenced in subsection (b) shall prevail over the boundary descriptions provided by the census tracts, blocks, and counties generated for the map."

54 Section 2. The provisions of this act are severable. If 55 any part of this act is declared invalid or unconstitutional, 56 that declaration shall not affect the part which remains.



Section 3. This act shall be effective for the election
of members of the state's U.S. Congressional districts at the
General Election of 2024 and thereafter, until the state's
U.S. Congressional districts are reapportioned and
redistricted after the 2030 decennial census.
Section 4. This act shall become effective immediately

63 upon its passage and approval by the Governor, or upon its 64 otherwise becoming law.
