4 SYNOPSIS:

This bill makes an appropriation of \$14,816,579 from the Education Trust Fund to Tuskegee University in Tuskegee, Alabama for the support and maintenance of the educational program of the institution, for the fiscal year ending September 30, 2025; provides that the appropriation is subject to certain provisions of the Code of Alabama 1975; requires an operations plan and an audited financial statement prior to the release of any funds; and requires an end of year report.

TO BE ENTITLED

17 AN ACT

To make an appropriation of \$14,816,579 from the Education Trust Fund to Tuskegee University in Tuskegee, Alabama, for the support and maintenance of the educational program of the institution, for the fiscal year ending September 30, 2025; to provide that the appropriation is subject to certain provisions of the Code of Alabama 1975; to require an operations plan and an audited financial statement prior to the release of any funds; and to require an end of year report.

28 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

29	Section 1. Tuskegee University has a unique
30	relationship to the State of Alabama. Due to the unique nature
31	of the circumstances related to the establishment and
32	development of Tuskegee Institute which differs from that of
33	private schools and colleges receiving funds from the state
34	and from the state's public colleges and universities, the
35	institution should be afforded a unique treatment relative to
36	funding from the Education Trust Fund. Tuskegee Institute was
37	established by an act of the Legislature in 1881 and
38	separately incorporated by an act of the Legislature in 1892;
39	the Governor appoints five commissioners who serve as voting
40	members on the Tuskegee University Board; and the State
41	Superintendent of Education serves as an ex officio voting
42	commissioner on the Tuskegee University Board. Tuskegee has
43	received appropriations from the Legislature since 1881. Being
44	a private institution as well as a state related and supported
45	institution, it is deemed that Tuskegee University should be
46	funded accordingly and not as the private schools and colleges
47	nor as the state public colleges and universities are funded.
48	Section 2. There is hereby appropriated the sum of
49	\$14,816,579 from the Education Trust Fund to Tuskegee
50	University in Tuskegee, Alabama, for the support and
51	maintenance of the educational program of the institution, for
52	the fiscal year ending September 30, 2025. Of the above
53	appropriation, at least \$2,000,000 shall be expended for the
54	agricultural research and extension service state match.
55	Section 3. The above appropriation is made for the
56	support of public education in Alabama and for the support and

- 57 maintenance of the above program. The appropriation shall be
- 58 subject to the provisions, terms, conditions, and limitations
- of the Budget and Financial Control Act, Section 41-4-80 et
- 60 seq., Code of Alabama 1975, the provisions of the Budget
- 61 Management Act of 1976, Section 41-19-1 et seq., Code of
- 62 Alabama 1975, and any other provisions of this act.
- 63 Section 4. (a) Prior to the release of any funds
- appropriated under this act the following reports shall be
- 65 submitted:
- 66 (1) An operations plan for the 2025 fiscal year,
- 67 including goals and measurable performance indicators, shall
- 68 be submitted to and approved by the Director of Finance, as
- 69 provided for state agencies in Section 41-19-10 of the Code of
- 70 Alabama 1975.
- 71 (2) An audited financial statement for all operations
- 72 during the 2023 fiscal year.
- 73 (b) It is the intent that funds appropriated for the
- 74 2025 fiscal year shall be released by the Director of Finance
- 75 following receipt of the above reports.
- 76 (c) In addition, quarterly reports shall be made to the
- 77 Director of Finance relating actual expenditures and
- 78 accomplishments to planned expenditures and accomplishments.
- 79 An end of year performance report for the 2025 fiscal year
- 80 shall be made to the Director of Finance stating the work
- 81 accomplished and the services provided and the costs of
- 82 accomplishing the work and providing the services, citing
- 83 meaningful measures of program effectiveness and costs, as is
- 84 required for state agencies in Section 41-19-11 of the Code of

- 85 Alabama 1975.
- 86 (d) The Director of Finance shall forward a copy of all
- 87 required reports to the Legislative Council in a timely
- 88 manner.
- Section 5. This act shall become effective October 1,
- 90 2024.
