SYNOPSIS:

Under existing law, in order to vote by absentee ballot, an elector must complete an absentee ballot application, which includes checking off the reason he or she wishes to vote by absentee ballot from a specified list of reasons. When the elector submits the absentee ballot to cast his or her vote, the elector must again check off the reason for voting absentee on the affidavit submitted with the absentee ballot.

This bill would remove from the affidavit form the list of reasons for voting by absentee ballot.

A BILL  
TO BE ENTITLED  
AN ACT

Relating to voting; to amend Section 17-11-7, Code of Alabama 1975, to remove from the affidavit that accompanies an absentee ballot certain information that was collected from the voter when the voter applied to vote by absentee ballot.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 17-11-7, Code of Alabama 1975, is amended to read as follows:

"§17-11-7

29 (a) Each absentee ballot shall be accompanied by an  
30 envelope upon which shall be printed an affidavit.

31 (b) With respect to an absentee ballot cast pursuant to  
32 Section 17-11-3, the affidavit shall read as follows:

53 ~~\_\_\_ I am a member of or a spouse or dependent of a  
54 member of the Armed Forces of the United States or am  
55 otherwise entitled to vote pursuant to the federal Uniformed  
56 and Overseas Citizens Absentee Voting Act, 42 U.S.C. 1973ff.~~

66 ~~have not been convicted of a felony involving moral turpitude.~~

67 I am entitled to vote an absentee ballot for the reason  
68 specified on my absentee ballot application.

69 I further swear (or affirm) that I have not voted nor  
70 will I vote in person in the election to which this ballot  
71 pertains.

72 I have marked the enclosed absentee ballot voluntarily  
73 and I have read or had read to me and understand the  
74 instructions accompanying this ballot and I have carefully  
75 complied with such instructions.

76 Moreover, I further swear (or affirm) that all of the  
77 information given above is true and correct to the best of my  
78 knowledge and that I understand that by knowingly giving false  
79 information so as to vote illegally by absentee ballot that I  
80 shall be guilty of a misdemeanor which is punishable by a fine  
81 not to exceed one thousand dollars (\$1,000) or confinement in  
82 the county jail for not more than six months, or both.

88 ACKNOWLEDGE OATHS, PRIOR TO BEING DELIVERED OR MAILED TO THE  
89 ABSENTEE ELECTION MANAGER, YOUR BALLOT WILL NOT BE COUNTED.

102 Section 2. This act shall become effective on January  
103 1, 2025.
