SYNOPSIS:

Existing law allows qualifying schools under the Alabama G.I. and Dependents Educational Benefit Act either to waive unpaid fees or to bill students for educational fees remaining unpaid after applying tuition reimbursement benefits from third parties.

This bill would require qualifying schools receiving tuition reimbursement benefits on behalf of veterans and their spouses, widows, or children under the act to make use of offsets and write offs of unpaid educational fees to the same extent as tuition reimbursement benefits received from the United States Department of Veterans Affairs.

30 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

31 Section 1. Section 31-6-15, Code of Alabama 1975, is
32 amended to read as follows:

33 "§31-6-15

34 (a) The benefits provided in this chapter shall be paid
35 from an annual appropriation from the Education Trust Fund to
36 reimburse every qualifying school in which benefits are given
37 to veterans and their spouses, widows, or children under this
38 chapter. Reimbursement shall be made timely at the end of each
39 academic quarter or semester for all tuition reimbursements
40 for the certified invoices submitted by the institution or
41 school to the State Department of Veterans' Affairs, and shall
42 be supported by names of the students receiving the benefits,
43 together with the amounts claimed for each student. Any amount
44 of in-state tuition, books, or fees not paid by the
45 combination of federal, state, and third party funds may be
46 billed to students receiving the benefits or waived by the
47 institution or school. Qualifying schools receiving tuition
48 reimbursement benefits on behalf of veterans and their
49 spouses, widows, or children under this chapter shall make use
50 of offsets and write-offs to the same extent as tuition
51 reimbursement benefits received from the United States
52 Department of Veterans Affairs.

53 (b) The Department of Examiners of Public Accounts may
54 audit the records of any two-year or four-year institution of
55 higher education that receives any reimbursement as a result
56 of this chapter to the same extent, degree, and scope as

57 audits performed on other public educational institutions. The
58 institution shall submit to the Legislature and the State
59 Department of Veterans' Affairs each year, before any
60 subsequent reimbursement may be applied for or considered, a
61 full accounting of any receipts, disbursements, assets,
62 liabilities, and other resources as of the date of the close
63 of the immediately preceding academic year."

64 Section 2. This act shall become effective on October
65 1, 2024.
