SYNOPSIS:

Under existing law, the membership of the Jacksonville State University Board of Trustees includes two at-large members; one of whom resides within this state and one of whom resides outside of this state.

This bill would increase and revise the at-large membership of the board to include four at-large members who reside either within or outside of this state.

A BILL
TO BE ENTITLED
AN ACT

Relating to Jacksonville State University; to amend Section 16-52-3, Code of Alabama 1975, to increase and revise the at-large membership of the board of trustees to include four at-large members who reside either within or outside of this state.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 16-52-3 of the Code of Alabama 1975, is amended to read as follows:

"§16-52-3

29 (a) There is created a Board of Trustees for
30 Jacksonville State University, the state educational
31 institution formerly known as Jacksonville State College at
32 Jacksonville, Alabama.

33 (b) The board of trustees shall consist of two members
34 from the congressional district in which the institution is
35 located, one from each of the other congressional districts in
36 the state, ~~one at-large member from the state, one~~ four
37 ~~at-large member from~~ members who reside either within or
38 ~~outside of~~ the this state, and the Governor, who shall be ex
39 officio president of the board.

40 (c) The trustees shall be appointed by the Governor, by
41 and with the advice and consent of the Senate and, ~~commencing~~
42 ~~on May 26, 2015,~~ shall be appointed to hold office for a term
43 of six years and until their successors shall be appointed and
44 qualified. No trustee shall be appointed to serve more than a
45 total of three full terms.

46 (d) No trustee shall receive any pay or emolument other
47 than his or her actual expenses incurred in the discharge of
48 his or her duties as such.

49 (e) A trustee who has attained the age of 75 years
50 during a term of office may continue to serve until the
51 expiration of that term. A trustee who has departed the board
52 and who has attained the age of 70 years or older may be
53 designated by the board as a Trustee Emeritus and may receive
54 such honorary privileges as conferred by the board.

55 (f) No employee of Jacksonville State University shall
56 be eligible to serve on its board of trustees."

57 Section 2. This act shall become effective on June 1,
58 2024.
