2 Relating to Elmore County; to amend Sections
3 45-26-81.01, 45-26-230.01, and 45-26-242.01, Code of Alabama
4 1975; to further provide for the compensation of the judge of
5 probate, sheriff, and revenue commissioner; and to repeal
6 Section 45-26-81, Code of Alabama 1975, relating to the salary
7 of the judge of probate.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. Sections 45-26-81.01, 45-26-230.01, and
10 45-26-242.01, Code of Alabama 1975, are amended to read as
11 follows:

12 "§45-26-81.01

13 (a) ~~Effective on July 1, 2020, the~~ The base annual
14 salary of the Judge of Probate of Elmore County shall be
15 ~~ninety-eight thousand dollars (\$98,000)~~ one hundred twenty
16 thousand dollars (\$120,000) per year, payable in equal monthly
17 installments from the general fund the same manner and at the
18 same time as other employees of the county. The salary
19 provided by this section shall supersede any salary, expense
20 allowance, or other compensation provided to the judge of
21 probate ~~prior to July 1, 2020.~~

22 (b) Notwithstanding any other law, in addition to any
23 other compensation provided to the judge of probate, the judge
24 of probate shall continue ~~after July 1, 2020,~~ to receive any
25 cost-of-living or other salary increases granted to county
26 employees or elected officials in the county and as approved
27 by the county commission or any salary increases as otherwise
28 granted and approved by the county commission."

38 term as Sheriff of Elmore County shall receive a salary in the
39 amount of one hundred thirty thousand dollars (\$130,000) per
40 year.

41 (c) Any individual who has previously served two full
42 terms as Sheriff of Elmore County shall receive a salary in
43 the amount of one hundred forty thousand dollars (\$140,000)
44 per year.

45 (d) Any individual who has previously served three or
46 more full terms as Sheriff of Elmore County shall receive a
47 salary in the amount of one hundred fifty thousand dollars
48 (\$150,000) per year.

49 (e) The salary~~salaries~~ provided by this section shall
50 be in lieu of any other salary provided by general or local
51 law and shall be paid in the same manner and at the same time
52 as other county employees."

80 Section 2. Section 45-26-81, Code of Alabama 1975,
81 relating to the salary of the judge of probate, is repealed.

82 Section 3. This act shall become effective on October
83 1, 2024.
