23	subject inside an apartment; he encouraged the subject to
24	unlock the door and helped him exit the apartment and get to
25	a safe place; TFD was nearby, and Deputy Washington notified
26	them of the need to treat the male subject; and
27	WHEREAS, there was a female subject still inside;
