

- 7 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

following criteria are met:

- Section 1. Notwithstanding any other provision of law,
 the state shall exercise concurrent jurisdiction with the
 United States over a military installation of the United
 States Department of Defense located within this state in a
 matter relating to a violation of federal law by a child, as
 defined in Section 12-15-102, Code of Alabama 1975, within the
 boundaries of that military installation, if both of the
- 16 (1) The United States Attorney or the United States
 17 District Court for the applicable district in this state
 18 waives exclusive jurisdiction.
- 19 (2) The violation of federal law is also a crime under 20 state law.
- 21 Section 2. When concurrent jurisdiction has been 22 established pursuant to Section 1, the juvenile court, as defined in Section 12-15-102, Code of Alabama 1975, has 23 24 exclusive original jurisdiction over any case involving a 25 child, as defined in Section 12-15-102, Code of Alabama 1975, 26 who is alleged to be delinquent as the result of an act 27 committed within the boundaries of a military installation 28 that is a crime under state law.
