5	This bill would relate to any Class 3
6	municipality organized under Act 618 of the 1973
7	Regular Session and would further provide for the
8	salary and expense allowance of the city council and
9	mayor.

12	TO BE ENACTED
13	AN ACT

15	Relating to any Class 3 municipality organized under
16	Act 618 of the 1973 Regular Session (Acts 1973, p. 879),
17	providing for the mayor-council form of government in certain
18	municipalities having a certain population according to the
19	1970 or any subsequent federal decennial census; to amend
20	Sections 45-51A-33.54 and 45-51A-33.93, Code of Alabama 1975,
21	to further provide for the salary and expense allowance of the
22	city council and mayor.
23	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
24	Section 1. This act shall apply only to any Class 3
25	municipality organized under Act 618 of the 1973 Regular
26	Session (Acts 1973, p. 879).
27	Section 2. Sections 45-51A-33.54 and 45-51A-33.93, Code
28	of Alabama 1975, are amended to read as follows:

29	"\$45-51A-33.54
30	(a) Commencing with the 1995 term, the council shall
31	receive such salary as the council, by resolution or by
32	ordinance, may prescribe. Such salary and the manner in which
33	it is to be paid, shall be established by the council. In no
34	event shall the council set the annual salary of the council
35	below eight thousand five hundred dollars (\$8,500) or above
36	eighteen thousand dollars (\$18,000).
37	(b) Effective October 1, 2024, in addition to the
38	salary authorized in subsection (a), the council shall receive
39	an additional annual expense allowance in the amount of twelve
40	thousand dollars (\$12,000) per year, payable in the same
41	manner as the salary authorized in subsection (a).
42	(c) Effective at the beginning of the 2027 term, the
43	council shall receive an annual salary of thirty thousand
44	dollars (\$30,000) per year and subsections (a) and (b) shall
45	be void and of no effect."
46	"\$45-51A-33.93
47	(a) Commencing with the 1995 term, the mayor shall
48	receive such salary as the council, by resolution or
49	ordinance, may prescribe. Such salary and the manner in which
50	it is to be paid, shall be established by the council. In no
51	event shall the council set the annual salary of the mayor
52	below fifty thousand dollars (\$50,000) or above ninety-five
53	thousand dollars (\$95,000).
54	(b) Effective October 1, 2024, in addition to the
55	salary authorized in subsection (a), the mayor shall receive

an additional annual expense allowance in the amount of

57	fifty-five thousand dollars (\$55,000) per year, payable in the
58	same manner as the salary authorized in subsection (a).
59	(c) Effective at the beginning of the 2027 term, the
60	mayor shall receive an annual salary of one hundred fifty
61	thousand dollars (\$150,000) per year and subsections (a) and
62	(b) shall be void and of no effect."
63	Section 3. This act shall become effective June 1,
64	2024.
