4	SYNOPSIS:
5	Under existing law, the Board of Trustees of the
6	Department of Archives and History is composed of two
7	members from each congressional district and two
8	at-large members.
9	This bill would revise the composition of the
LO	board to the Governor and eight at-large members
L1	appointed by the Governor, Lieutenant Governor, Speaker
L2	of the House of Representatives, and Speaker Pro
L3	Tempore of the Senate.
L 4	Under existing law, vacancies on the board are
L 5	filled by the board.
L 6	This bill would authorize the respective
L 7	appointing authorities to fill vacancies on the board.
L 8	This bill would also make nonsubstantive,
L 9	technical revisions to update the existing code

7	Relating to the Department of Archives and History: to

27 Relating to the Department of Archives and History; to 28 amend Sections 41-6-3 and 41-6-4, Code of Alabama 1975; to



- 29 further provide for the composition of the Board of Trustees
- of the Department of Archives and History; to further provide
- 31 for the filling of vacancies on the board; and to make
- 32 nonsubstantive, technical revisions to update the existing
- 33 code language to current style.
- 34 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
- 35 Section 1. Sections 41-6-3 and 41-6-4, Code of Alabama
- 36 1975, are amended to read as follows:
- 37 "\$41-6-3
- 38 (a) The department shall be under the control of the
- 39 Board of Trustees of the Department of Archives and History,
- 40 which shall consist of one member from each congressional
- 41 district and the additional members selected pursuant to
- 42 subsection (b) eight at-large members and the Governor or his
- 43 or her designee.
- 44 (b) Two additional at-large members shall be selected
- 45 and an additional member shall be selected from each U.S.
- 46 Congressional District. The additional members shall be
- 47 selected by the board of trustees and their names shall be
- 48 communicated to the Senate not later than the fifth
- 49 legislative day of the 2004 Regular Session of the
- 50 Legislature. On June 1, 2024, all individuals then serving on
- 51 the board shall be removed and replaced with new members. The
- 52 Governor, Lieutenant Governor, Speaker of the House of
- 53 Representatives, and Speaker Pro Tempore of the Senate shall
- each select one member to serve an initial term of two years
- and one member to serve an additional term of four years.
- Newly selected members shall be confirmed by the Senate in the



57 same manner as vacancies filled pursuant to Section 41-6-4.

58 The board of trustees shall select three of the new members to

59 serve initial terms of two years, three of the new members to

60 serve initial terms of four years, and three of the new

61 members to serve initial terms of six years. All successor

62 members shall serve terms of six years and shall be selected

- (c) The membership of the board of trustees shall be inclusive and shall reflect the racial—and, gender, geographic, urban, rural, and economic diversity of the state.
- (d) All new and successor members shall serve at the pleasure of their respective appointing authority."

- (a) The board of trustees respective appointing authorities described in Section 41-6-3(b) shall fill all vacancies occurring on the board, whether by expiration of term of service or by death or resignation, but the names of all successor members shall be communicated to the current session or the next ensuing regular session of the state Senate for confirmation. If the Senate rejects any successor trustee, the board respective appointing authority shall proceed forthwith to fill the vacancy.
- (b) A trustee appointed to succeed a member whose term has expired shall serve for a term of six years. A person An individual appointed to fill a vacancy occurring by death or resignation shall only serve out the unexpired term of his or her predecessor. A person An individual whose appointment to the board has been confirmed by the Senate shall serve beyond



his or her expired term until a successor has been confirmed by the Senate.

- (c) The board shall hold at the State Capital at least 87 88 one regular meeting during every year and as many special 89 meetings as may be necessary, and at any meeting a majority of 90 the trustees shall constitute a quorum. The Governor of the 91 state shall be a voting member of the board as authorized by 92 Section 41-6-3, and he or she shall, as far as possible, shall 93 lend every encouragement to the success and upbuilding development of the department. The director shall be the 94 95 secretary of the board. The trustees shall receive no compensation for their services. Each member of the board of 96 97 trustees shall be reimbursed at the same per diem and travel 98 allowance amounts paid by law to state employees for each day 99 of attendance of the business of the board.
 - (d) The board may do all of the following:

- 101 (1) Adopt rules for its own government and also for the government of the department.
- 103 (2) Elect a director and provide for the selection or
 104 appointment of other officials or employees as may be
 105 authorized.
 - (3) Provide for the publication of historical material pertaining to the state under the supervision of the director.
- 108 (4) Control and expend such appropriations as may be
 109 made for the maintenance of the department.
- 110 (5) Perform such other acts as may be necessary to
 111 carry out the intent and purposes of this article."
- Section 2. This act shall become effective on June 1,
