

8	passing of Charles "Charlie" Luker of Birmingham, Alabama,
9	on April 18, 2024, at the age of 74; and
10	WHEREAS, his passing leaves a void in the lives of
11	his loving family, many friends, and the community where he
12	was highly regarded; and
13	WHEREAS, Charlie Luker was born on September 29,
14	1949, to Lafe and Mary Ellen Rogers Luker; he was a lifelong
15	devoted servant of his Lord and Savior, Jesus Christ, and
16	dedicated his life to service in his church and his

18	WHEREAS, Mr. Luker was elected to serve as Coosa
19	County Tax Assessor in 1978 and served until March 2013;
